Selection & Interview:

The candidates should attend the selection process & interview scheduled to be conducted on 29/01/2026, Certificate verification will start at 9.30 AM and the interview will be conducted at 10.30 AM onwards. Candidate should bring all relevant documents & certificates and reach the office of the Krishi Vigyan Kendra Kottayam, Kavanattinkara , Kumarakom ,Kottayam in time.

Terms & Conditions

- i. The candidate must be a citizen of Indian and shall not be over 50 years as on 01.01.2026.
- ii. Reservation benefit will be allowed as per the norms of Kerala Public Service Commission on production of Community Certificate (in the case of SC/ST),

'Non-Creamy Layer certificate' (in the case of OBC), Disability certificate (in the case of differently abled) issued by the competent authority.

- iii. PG candidates in the relevant discipline will be considered in the absence/shortage of NET/Ph.D holders.
- iv. The appointment will be on contract basis and purely provisional for a period of one year or till the appointment of regular hands in the post, whichever is earlier.
- v. The candidates will have no claim in the University other than the right to receive the consolidated remuneration of Rs.44,100/- per month attached to the post. The appointment will not confer on him/her any right of permanency or regularization in Kerala Agricultural University.
- vi. Selected candidates will be eligible for one casual leave per month subject to a maximum of TEN per year.
- vii. The candidates should have prescribed qualification on the date of application.
- viii. No TA/DA will be paid for attending interview.
- ix. An agreement in the prescribed form will be executed by the candidate in Stamp paper worth Rs. 200/-, if selected for appointment.
- x. The candidate, if selected will discharge all such duties that are attached to the post as per KAU Act/Statutes/Regulation & Rules and that may be assigned to him/her from time to time by the Head of Institution.
- xi. After appointment, the candidate can discontinue from the contract with one month prior notice.
- xii. The undersigned has the right to terminate the services of appointees if the performance is found unsatisfactory or any such defects noticed without any notice.
