Terms and Conditions

- Period of appointment: The appointment is purely temporary and on contract basis. The
 appointment will be for a period of three years in case the duration of the projet is
 extended by the funding agency or till the completion of the project, whichever is earlier.
 There is no provision for re-employment after the termination of appointment.
- 2. Age: Maximum age should not be above 40 years as on 01.01.2021. Age relaxation as per existing Government rules will be granted to eligible candidates.
- 3. Remuneration: Rs.54,000/- (for Doctoral Degree holders) and Rs.49,000/- (for Masters Degree holders) per month.
- 4. If needed a written test will also be conducted for the discipline concerned, before the commencement of the interview.
- 5. No TA/DA will be paid for attending the walk-in-Interview.
- 6. An agreement in the prescribed form should be executed by the candidate in Stamp Paper worth Rs. 200/-, if selected for appointment.

- 7. The candidates will have no claim in the University other than to receive the pay attached to the post.
- 8. The appointment will not confer him/her any right of permanency or regularisation in KAU.
- 9. The candidate, if selected will discharge all such duties that are attached to the post and that may be assigned to him/her from time to time by the Head of Department.
- 10. The University has the right to terminate the service of temporary appointment if the performance is found unsatisfactory or any such defects noticed.
