NOTIFICATION**GA/E3/5577/2013****Date: 16/06/2023**

In exercise of the powers conferred under sub section (2) (b) of Section 12 of the Kerala Agricultural University Act 1971 (Act 33 of 1971) the General Council of the Kerala Agricultural University has been pleased to issue the following further amendments to Statute issued in Notification No. GA/E3/16130/91 dated 14/06/2008 and as assented to by the Chancellor with effect from 04/06/2023 under section 49(6) of the said Act.

AMENDMENTS**In the said statutes: -**

- 1) The term 'Peon' wherever occurs shall be substituted with 'Office Attendant'.
- 2) The clause 2 the method of appointment for the post "Class IV" shall be substituted by the following.

Method of Appointment

The method of appointment to the Class IV posts in various categories mentioned in clause 7 shall be as follows: -

- (i) 50% of the vacancies by Direct Recruitment.
- (ii) 50% of the vacancies by appointment from among Permanent Labourers and Plantation Workers (Permanent Labourers 90% Plantation workers 10%)

In the absence of Plantation Workers, the vacancy shall be filled from among permanent labourers.

- 3) The clause 3 the qualification for the post shall be substituted by the following.

Qualifications: – No person shall be eligible for appointment to the post unless he possesses the qualifications mentioned below:

Qualification**A. Direct Recruitment**

- i) Pass in Std VII and should not have acquired any degree.
- ii) Good physique.

B. Internal selection

Pass in Std VII and should not have acquired any degree.

- 4) New posts "Class IV Grade I" is added to the existing statute with the method of appointment as detailed below

Class IV Grade I**Method of Appointment**

By promotion from the post of Class IV Grade-II (Entry Cadre of Class IV posts) according to seniority and availability of vacancy.
