2. **Earnest Money Deposit:** An EMD of **Rs.27,000/-- (Rupees Twenty Seven Thousand only)** should be remitted by separate DD drawn in favour of Associate Director, Regional Agricultural Research Station. Pilicode Pin-671310.

#### Agreement:-

3. The tender should be accompanied by an Agreement in Kerala stamp paper worth Rs.200/-(Rupees Two hundred only) in the format that can be downloaded from the website [www.kau.edu/tenders](http://www.kau.edu/tenders) OR [rarspil.kau.in/tenders](http://rarspil.kau.in/tenders).
4. The sealed cover containing the tender documents should be super scribed as “Tender for combined harvester” **The cover should contain the DDs for tender cost, GST, EMD and the Agreement as mentioned above.**


