- 2. Earnest Money Deposit:** An EMD of **Rs.1,900/-- (Rupees One Lakh Ninety Thousand Only)** should be remitted by separate DD drawn in favour of Associate Director, Regional Agricultural Research Station. Pilicode Pin-671310.

Agreement:-

- 1 The tender should be accompanied by an Agreement in Kerala stamp paper worth **Rs.200/-(Rupees Two hundred only)** in the format that can be downloaded from the website www.kau.edu/tenders OR rarspil.kau.in/tenders.
- 2 The sealed cover containing the tender documents should be super scribed as **“Tender for construction of Agro service center”** .The cover should contain the DDs for tender cost, GST, EMD and the Agreement as mentioned above.
