2. EMD amount of Rs.1500/- should be remitted along with the tender cost, by separate Demand Drafts drawn in favour of Associate Director of Research, Regional Agricultural Research Station, Pattambi, payable at State Bank of India, Pattambi.
3. Documents to be submitted.
  - Company Data sheets, Brochures & other documents such as relevant technical literatures, drawings, pamphlets containing all the relevant technical specifications of the equipment duly signed by the bidder on each page

5. Tenders will be accepted up to 3 pm on 18.03.2025. Tenders received after the stipulated time will not be accepted.
6. Tenders will be opened at 3.30 pm on the same day in the presence of those bidders who are present at that time.
7. The bidder of the accepted tender should enter into an agreement with the Associate Director of Research, Regional Agricultural Research Station, Pattambi on Kerala stamp paper worth Rs. 200/-. He should also submit a security deposit equal to 5% of the cost of above mentioned items in the form of Term Deposit/Bank Guarantee/Demand Draft

12. All other technical and commercial terms and conditions as per the code rules in force in Kerala State will be applicable in this case also.


**Special Conditions.**
