- Tenders not stipulating period of firmness of rates and with price variation clause and/or subject to prior sale condition are liable to be rejected.
- The items should be delivered at the expenses of the successful bidder.
- Rate quoted should be inclusive of all charges such as packing, forwarding, freight, loading/unloading/handling and Government duties leviable, if any.
- Documents to be submitted:
 - Tender form: Each and every pages of the tender form should be attested after reading the conditions provided.
 - Copy of up-to-date GST registration certificate & PAN of the bidder
 - Authorization certificate if the bidder is a dealer.
 - EMD @ 1% of the quoted amount should be submitted as separate DD drawn in favour of **Professor and Head, Farming Systems Research Station, Kerala Agricultural University, Sadanandapuram, "payable at State Bank of India, Pulamon Junction Branch, Kottarakara, Kollam** along with an agreement executed in Kerala stamp paper worth Rs. 100/- should be enclosed with the tender. Valid EMD exemption certificate from the Store Purchase Department, Govt. of Kerala, if the firm is exempted from payment of EMD.  - Undertaking to the effect that the bidder is not Debarred/ Blacklisted or Banned from any University/ Government Institute / PSU.

 - The tender notice number, name of the items for which the rate is quoted and date of opening of tender should also be mentioned on the top of the envelope.
 - Late tenders will not be accepted.
- The items should be delivered at the "Professor and Head, FSRS Sadanandapuram, Sadanandapuram P.O, Kottarakkara – 691 531" at your own expenses and any packing, forwarding, freight, loading/unloading/handling will be met by the firm.
 - Details required for e-payment (Details of bank account having core banking facility and email address of the bidder) shall be furnished along with the tender.
 - Payments will be made only after the supply is actually verified and taken to stock.
 - Tenders not accompanied by these details will be rejected.
 - Professor and Head, Farming Systems Research Station, Sadanandapuram shall have no obligation to convey reason for rejection of any bid. It shall be open for Professor and Head, Farming Systems Research Station, Sadanandapuram to reject even the lowest bidder in the interest of the University and no reason need be given therefore.
 - On receipt of purchase order from this office, the tenderer should furnish a security deposit of 5% of the cost of the items quoted in the form of term deposit / bank guarantee / demand draft in favour of "Professor and Head, Farming Systems Research Station, Sadanandapuram" payable at State Bank of India, Pulamon Junction Branch, Kottarakkara, Kollam (IFSC Code: SBIN0070272).
 - Withdrawal from the tender after it is accepted or failure to supply within a specified time or according to specifications will entail cancellation of the order.
 - The items should be delivered at "Farming Systems Research Station, Kerala Agricultural University, Sadanandapuram, Kottarakkara, Kollam-691531" at your own expenses and any packing, forwarding, freight, loading/ unloading/ handling will be met by the firm.
 - All subsequent Government orders connected to tenders and any revision in the rate so taxes would also be applicable to this tender'
