2. The sealed cover containing the tender documents should be superscribed as Limited Tender for Talc" along with the notification number) and addressed to **The Associate Professor & Head, Rice Research Station, Vyttila P.O,Ernakulam - 682 019.**
3. Each tender should be accompanied by tender fee and an Earnest Money Deposit (EMD) at 2.5 % of the total cost of item and remitted by a separate DD drawn in favour of the Associate Professor & Head, Rice Research Station, Vyttila". Late and incomplete tenders and tenders without EMD, tender fee and agreement will not be accepted. Firms who are exempted from payment of EMD should furnish copy of the currently valid certificate from the store Purchase Department, Govt. of Kerala.

4. The Tender should be accompanied by an agreement in Kerala Stamp paper worth Rs.200/- (Rupees Two hundred only) and format can be downloaded from the KAU website ([www.kau.in](http://www.kau.in)). Withdrawal of tenders after its acceptance or failure to supply the item or not according to the specifications will entail cancellation of the tender.

The successful tenderer should execute an agreement in Kerala Stamp paper worth Rs.200/- (Rupees Two hundred only) and furnish a security deposit of 5 % of cost of the item quoted in the form of demand draft drawn in favour of Associate Professor & Head, Rice Research Station ,Vytila payable at SBI,Vytila .The format of the agreement can be downloaded from the KAU website ([www.kau.in](http://www.kau.in))
6. The cost of the item, tax and other charges should be separately stated. Prices quoted should be valid upto one year.

The item should be supplied at our premises and the item transporting vehicle with the talc and empty vehicle should be weighed in a Government authorized weighing bridge near to the station in the presence of an office representative and item should be supplied at our biocontrol lab store room .The item will be supplied within one month after placing the work order.
8. If any bandh/strike/any unexpected holidays occurs on the date of opening of quotation, the quotation will be opened at the same time on the text working day.
9. Payment will be made only as A/c payee cheque and 2 % GST TDS will be deducted from the bill.
