If exempted from payment of EMD a valid certificate from the store Purchase Department, Govt. of kerala should be furnished.

The sealed cover containing the tender should be superscribed "Tender for the supply of 3KVA Portable Generator with Self Starter" (along with the notification number) and addressed to the Associate Director, Regional Agricultural Research Station, Kumarakom, Kottayam Dist., Kerala PIN 686 563.

- 8. The Equipment should be packed well with necessary caution slip and also be insured against damage in transit at the own expenses of the tenderer. The payment as per the invoice will be made only on receipt of the articles in good condition as per specifications and satisfactory installation.
- Tenderor is liable to replace the deffective articles immediately on receipt of intimation.
   Any failure on the part of the supplier in the fullfillment of contractual obligation will result in the forfeiture of EMD/ Security Deposit.
- 10. The supply order will be issued on the acceptance of the tender and the invoice should be addressed to Associate Director, Regional Agricultural Research Station, Kumarakom, Kottayam dist., kerala, PIN 686563. The payment will be effected only after satisfactory supply of the items.
- 11. The tenderer should supply the items to RARS, Kumarakom within 15 days from the date of the receipt of the supply order.
