Sealed and competitive tenders are invited from the original manufactures or dealers for the supply of the power tiller having the following specification and subject the below stated terms and conditions. Only highly reliable & reputed brands with long standing in the industry and wide service channels and proven guaranteed long system-life standards are considered.

- Power Tiller(suitable for wetland ploughing)-12 HP Diesel Operated.
- Cage wheel/ Steel wheel type IV
- Tail skid- Long
- Power tiller kit(farmers kit).
- Tilling Blade(R- Qty 40)
- Tilling Blade-(L- Qty- 40)
- Tilling width (60cm)

**Terms and condition:-**

1. Tender should be submitted in the prescribed form which can be downloaded from the web link [www.rarsptb.kau.in/tenders](http://www.rarsptb.kau.in/tenders). The cost of tender form is Rs. 600/- + 18% GST (ie. Total amount of Rs. 708/-) which will be accepted by way of Demand Draft drawn in favour of "Associate Director of Research, Regional Agricultural Research Station, Pattambi" payable at State Bank of India, Pattambi.
2. The tender should be accompanied by an agreement in Kerala stamp paper worth Rs. 200/- (Rupees Two Hundred only), the format of which can be downloaded from the above website. Withdrawal of tenders after its acceptance or failure to supply the items or not according to the specification will entail cancellation of tender.
3. EMD amount of Rs. 3000/- should be remitted along with the tender cost of Rs. 708/- by two separate Demand Drafts drawn in favour of Associate Director of Research, Regional Agricultural Research Station, Pattambi payable at State Bank of India, Pattambi. No other Demand Draft will be entertained.
4. The sealed cover containing the tender should be super scribed as "Tender for the supply Power Tiller with Accessories" as per tender notice No. D3- 1185/2023 dtd 18.03.2023
5. Tenders will be accepted up to 2 pm on 28.03.2023. Tenders received after the stipulated time will not be accepted.
6. Tenderers claiming exemption from paying EMD should produce necessary evidence/ documents in support of their request
7. Tenders will be opened at 2.30 pm on the same day at the presence of those bidders who are present at that time.

8. The bidder of the accepted tender should enter into an agreement with the Associate Director of Research, Regional Agricultural Research Station, Pattambi on Kerala stamp paper worth Rs. 200/-. The format of the agreement is available in the web link [www.rarsptb.kau.in/tenders](http://www.rarsptb.kau.in/tenders). He should also submit a security deposit equal to 5% of the cost of above mentioned items in the form of Term Deposit/Bank Guarantee/Demand Draft drawn in favour of Associate Director of Research, Pattambi payable at State Bank of India, Pattambi.
9. The cost of item including GST and transportation charges is to be mentioned in tender. The brand/make/warranty etc. of the item should be mentioned in the tender.
10. The items should be supplied in accordance with the supply order issued from this office and installed accordingly and their working has to be demonstrated satisfactorily.
11. The supplier should give the details of the nearest service center and response time etc.
12. Payment of cost of the items will be made by invoice cum cheque basis.
13. Any failure on the part of supplier in the fulfillment of contractual obligations will result in the forfeiture of EMD/Security Deposit.
14. All other technical and commercial terms and conditions as per the code rules in force in Kerala State will be applicable in this case also.
