- 2. Each tender should be accompanied by Earnest Money Deposit (EMD) of 1% of the cost of the quoted items (subject to minimum of Rs.1500/-) by way of two crossed Demand Drafts separately for tender fee and EMD drawn in favour of the Senior Deputy Comptroller Internal Audi Circle(SR), Vellayani payable at State Bank of India, Vellayani. - 9. The supply order will be placed immediately on the confirmation of the tender and availability of funds.
- 10. The period of warranty for the items should be stated separately.
- 11. Tenders insisting payment in advance either full or part are liable for rejection.
