Quotation Notice

Sealed competitive quotations are invited from the manufactures / dealers on or before 3.00 PM on 21/03/2025 for the "Supply and installation of Convertible side by side door refrigerator having deep freezer" for Tissue culture lab with following features.

Specifications :-

- Capacity: 600 Ltr or above.
- Star rating:-3 star or above
- Make :- Blue Star/Haier/LG.
- Full Warranty on machine :- 2 years minimum.
- Compressor warranty: 10 years minimum.
- PCB warranty :- 5 years minimum.
- Contains roller/wheel for easy movement.

The envelopes containing the quotation should bear the superscription "Quotation for the supply and installation of Convertible side by side door refrigerator having deep freezer for Tissue culture lab of Banana Research Station Kannara" and should be addressed to Professor & Head, Banana Research Station Kannara. Intending quotationers may submit the quotations on their own papers. Last date for receipt of quotations is 21-03-2025 at 12.00 PM. Any quotation received after the time fixed on the due date is liable to be rejected. The quotations will be opened at 12.30 pm on 21-03-2025 itself, in the presence of such of the quotationers or their authorized representatives who may be present at that time. Details of the requirements and the conditions governing their supply can be obtained free on request from the office during office hours.

TERMS AND CONDITIONS

- 1. The rates quoted should include delivery of the article at the place mentioned above.
- 2. The prices quoted should be inclusive of all taxes, duties, cesses, etc., which are or may become payable by the contractor under existing or future laws or rules of the country of origin/supply or delivery during the course of execution of the contract. The quotations shall quote also the percentage of rebate (discount) offered by them.
- 3. The maximum period required for delivery of the articles should be mentioned.
- 4. Equipment furnished shall be complete in every respect with all mountings, fittings, fixtures and standard accessories normally provided with such equipment's and/or needed for erection, completion and safe operation of the equipment's as required by applicable codes though they may not have been specifically detailed in the tender document.

- 5. The supplier has to make his own arrangement for the ordinary/special tools, machinery, and other consumables required for successful completion of installation and testing.
- 6. Professor and Head, Banana Research Station shall have no obligation to convey reason for rejection of any bid. It shall be open for Professor and Head to reject even the lowest bidder in the interest of the University and no reason need be given therefore.
- 7. Payments will be made only after the supplies are actually verified and taken to stock.
- 8. The maximum period required for delivery and installation of the article should be with in one week after the receipt of supply order.
- 9. Quotations not stipulating period of firmness of rates and with price variation clause and/or 'subject to prior sale' condition are liable to be rejected.
- 10. Details of warranty from manufacturer, extended warranty if any, rate for extended warranty, rate for annual maintenance cost after warranty period etc., should be mentioned.
- Withdrawal from the quotation after it is accepted or failure to supply within a specified time or according to specifications will entail cancellation of the order. In such cases, the purchases may be made from other sources at the offerer's expense any loss incurred there by being payable by the defaulting party.
- 12. In such an event the Government reserves also the right to remove the defaulter's name from the list of Government suppliers permanently or for a specified number of years.
- 13. No representation for enhancement of price once accepted will be considered during the currency of the contract.
