Sealed competitive tenders are invited for the supply of non – lab grade chemicals for the use of this station.

Terms and condition:-

1. Tender should be submitted in the prescribed form which can be downloaded from the web link <https://kau.in/tenders>. The cost of tender form will be accepted by way of Demand Draft drawn in favour of Professor and Head, Farming Systems Research Station, Sadanandapuram payable at State Bank of India, Pulamon Junction and should be enclosed along with the tender. The tender cost and GST amount (12%) should be specified while submitting the tender.

Cost of Tender form	
Suppliers costing between Rs. 1,00,000/- and 10,00,000/-	0.2% of the quoted amount rounded to the nearest multiple of Rs.100/- subject to a minimum of Rs.400/- and maximum of Rs. 1,500/- + GST 12%
Suppliers costing more than Rs. 10,00,000/-	0.15% of the quoted amount rounded to the nearest multiple of Rs. 100/- subject to a maximum of Rs. 25,000/- + GST 12%

2. The tender should be accompanied by an agreement in Kerala stamp paper worth Rs. 200/- (Rupees Two Hundred only), the format of which can be downloaded from the above website. Withdrawal of tenders after its acceptance or failure to supply the items or not according to the specification will entail cancellation of tender.

3. EMD @ 1% of the amount offered (subject to a minimum of Rs 1,500/-) should be remitted along with the tender cost and GST amount mentioned above by two separate Demand Drafts drawn in favour of Professor and Head, Farming Systems Research Station, Sadanandapuram payable at State Bank of India, Pulamon Junction. No other Demand Draft will be entertained.
4. The sealed cover containing the tender should be super scribed as "Tender for non lab grade Chemicals for AYAR and Sampoorana production as per tender notice No. 2076/24 dtd 10.12.2024
5. Tenders will be accepted up to 2 pm on **23.12.2024**. Tenders received after the stipulated time will not be accepted.
6. Tenders will be opened at 2.30 pm on the same day at the presence of those bidders who are present at that time.
7. The bidders who already submitted their Tenders need not submit the same again.
8. The bidder of the accepted tender should enter into an agreement with the Professor and Head, Farming Systems Research Station, Sadanandapuram, Kottarakkara on Kerala stamp paper worth Rs. 200/-. The format of the agreement is available in the web link <https://kau.in/tenders>. He should also submit a security deposit equal to 5% of the cost of chemicals in the form of Term Deposit/Bank Guarantee/Demand Draft drawn in favour of Professor and Head, Farming Systems Research Station payable at State Bank of India, Pulamon Junction.
9. Analysis report of chemicals obtained from accredited laboratory should be provided for each lot supplied. The items supplied will be analyzed for qualities at this end also before settling the invoice
10. The chemicals should be supplied in lots as required.
11. Payment of cost of the chemicals will be made by invoice cum cheque basis.
12. Any failure on the part of supplier in the fulfillment of contractual obligations will result in the forfeiture of EMD/Security Deposit.
13. All other technical and commercial terms and conditions as per the code rules in force in Kerala state will be applicable in this case also.

Special Conditions.

1. Tenders insisting payment in advance either full or in part for releasing the documents through bank are liable to be rejected.
2. The undersigned reserves the authority to accept or reject any or all of the offers for chemicals without assigning any reason whatsoever.
