Sealed tenders on competition basis are invited for the supply of furniture to Institute of Agricultural Technology, and Hostels, of this station, subject to the following terms and conditions detailed below.

1.	<u>Steel Table</u> <ul style="list-style-type: none">• Steel table with one cupboard and one drawer with 18 mm laminated board top• The table should be made of steel round pipe or square pipe with 22 gauge thickness• Size – 3ft. x 1.5ft x 2 ft (length x width x height)
2.	<u>Steel Cot</u> <ul style="list-style-type: none">• The cot should be made of steel frames & steel top• Dimension 6.25ft x 3ft x 1.5 ft (length x width x height)• 20 Gauge metal sheet on top
3.	<u>Plastic chair with arm</u> <ul style="list-style-type: none">• Should be made from virgin plastic
4.	<u>Plastic chair without arm</u> <ul style="list-style-type: none">• Should be made from virgin plastic
5.	<u>Study chair</u> <ul style="list-style-type: none">• The complete structure of the chair should be made of steel with a thickness of 20 gauge and painted black• Laminated wooden writing pad size 2ft. width, covering both arms• Dimension – Seat 45 x 42 cm, Back 45 x 37 cm, Height – 30 inch• Seat & back should be made of perforated steel plate of 20 gauge thickness

Terms and condition:-

1. Tender should be submitted in the prescribed form which can be downloaded from the web link www.rarsptb.kau.in/tenders. The cost of tender form is Rs. 1000/- + 18% GST (ie. Total amount of Rs. 1180/-) which will be accepted by way of Demand Draft drawn in favour of "Associate Director of Research, Regional Agricultural Research Station, Pattambi" payable at State Bank of India, Pattambi and should be send separately along with the tender.
2. The tender should be accompanied by an agreement in Kerala stamp paper worth Rs. 200/- (Rupees Two Hundred only), the format of which can be downloaded from the above website. Withdrawal of tenders after its acceptance or failure to supply the items or supply of items inconsistently with the specification will entail cancellation of tender.
3. EMD amount of Rs. 5000/- should be remitted along with the tender cost of Rs. 1180 /- by two separate Demand Drafts drawn in favour of Associate Director of Research, Regional Agricultural Research Station, Pattambi payable at State Bank of India, Pattambi. No other Demand Draft will be entertained.
4. The sealed cover containing the tender should be super-scribed as "Tender for Supply of Furniture as per tender notice No. D3- 4277 dtd 13.03.2024.
5. Tenders will be accepted up to 2 pm on 27.03.2024. Tenders received after the stipulated time will not be accepted.
6. Tenders will be opened at 2.30 pm on the same day at the presence of those bidders who are present at that time.
7. The bidder of the accepted tender should enter into an agreement with the Associate Director of Research, Regional Agricultural Research Station, Pattambi on Kerala stamp paper worth Rs. 200/-. The format of the agreement is available in the web link www.rarsptb.kau.in/tenders. The EMD of the accepted bidders will be adjusted to Security Deposit which will be refunded after the period of contract.
8. Payment of cost of the furniture will be made by invoice cum cheque basis.
9. Any failure on the part of supplier in the fulfillment of contractual obligations will result in the forfeiture of EMD/Security Deposit.
10. All other technical and commercial terms and conditions as per the code rules in force in Kerala State will be applicable in this case also.

Special Conditions.

1. Tenders insisting payment in advance either full or in part for releasing the documents through bank are liable to be rejected.
2. The undersigned reserves the authority to accept or reject any or all of the offers for chemicals without assigning any reason whatsoever.
